DISCUSSION WITH SHERIFF BRETT STASSI CONCERNING ACADIAN AMBULANCE SERVICES AND RELATED MATTERS.

Iberville Parish Sheriff Brett Stassi introduced Acadian Ambulance Operations Manager, Capital District Justin K. Cox and Director of Operations Porter Taylor. Mr. Cox provided information concerning their service to Iberville Parish.

DISCUSSION WITH IBERVILLE PARISH SALES & USE TAX DIRECTOR DAVID HALL AND ADOPT A RESOLUTION IN OPPOSITION OF ALL PROPOSED LEGISLATION THAT TRANSFERS THE ADMINISTRATION AND COLLECTION OF LOCAL SALES & USE TAXES AND OCCUPATIONAL LICENSE TAXES TO THE LOUISIANA DEPARTMENT OF REVENUE.

Selectman Oscar S. Mellion and was unanimously seconded by Selectmen Lindon A. Rivet, Jr., Ralph J. Stassi, Jr., Russell L. Gerace, Timothy L. Martinez and Jimmie Randle, Jr.:

A RESOLUTION IN OPPOSITION OF ALL PROPOSED LEGISLATION THAT TRANSFERS THE ADMINISTRATION AND COLLECTION OF LOCAL SALES & USE TAXES AND OCCUPATIONAL LICENSE TAXES TO THE LOUISIANA DEPARTMENT OF REVENUE

WHEREAS, the Constitution of the State of Louisiana grants local governments the right to levy and collect local sales and use taxes and occupational license taxes;

WHEREAS, there are several constitutional amendments and bills introduced in the 2020 Regular Legislative Session, that would transfer collection responsibility of local sales and use tax and occupational license tax levies to the State Department of Revenue or other entity, namely HB 428, HB 429 and HB 581; and

WHEREAS, local taxing authorities possess the best knowledge and experience to properly collect its own taxes and have a proven record of proactive advancements in the areas of enforcement, audit coverage, dispute resolution, reporting technology and successful litigation; and

WHEREAS, the State of Louisiana's budget issues do not offer prospects for the Department of Revenue or other entity to have sufficient resources to provide the necessary taxpayer assistance, enforcement programs and training of its employees on the specific application or local sales and use tax and occupational license tax ordinances without significant cost contributions from local governments, thereby resulting in the direct and indirect loss of local tax receipts; and

WHEREAS, many local taxing authorities have issued bonded indebtedness guaranteed by the passage locally adopted sales and use tax levies, collection of said levies are the direct responsibility of local governments, and the transfer of that responsibility to a state agency may generate legal challenges and jeopardize future bond issues; and

WHEREAS, the central local collector of sales and use taxes in each parish is directly responsible to the local taxing authorities and their elected officials for the performance of local tax administration, and the Secretary of the Department of Revenue being an appointee of the Governor of the State, uncertainty exist as to who in the Department of Revenue or other entity will be accountable to local taxing authorities for the performance of such critical local tax administration,

NOW THEREFORE, **BE IT RESOLVED**, that the City of Plaquemine, through its Mayor and Board of Selectmen, as a local taxing authority and/or governing body, that each member of the

legislative delegation for the Parish of Iberville is urged to vigorously oppose any and all proposed legislation that transfers the administration and collection of local sales and use taxes and occupational license taxes to the Louisiana Department of Revenue or other entity; and

BE IT FURTHER RESOLVED, that a copy of this resolution be sent forthwith to said legislators so that they will be made aware of our position on this matter.

ADOPT AN ORDINANCE TO AMEND CHAPTER 23, SECTION 41(D), SECTION 42(D), TABLE 3.1 MINIMUM LOT AND YARD SIZE REQUIREMENTS FOR R-6 AND R-4 ZONING DISTRICTS AND OTHER MATTERS RELATED THERETO.

Selectman Lindon A. Rivet, Jr. offered the following ordinance, seconded by Selectman Russell L. Gerace:

ORDINANCE NUMBER: 390

AN ORDINANCE TO AMEND CHAPTER 23, SECTION 41(d), SECTION 42(d), TABLE 3.1 MINIMUM LOT AND YARD SIZE REQUIREMENTS FOR R-6 AND R-4 ZONING DISTRICTS AND OTHER MATTERS RELATED THERETO

WHEREAS, the Plaquemine Planning and Zoning Commission published in the Plaquemine Post/South, official journal for the City, on December 19, 2019, December 26, 2019 and January 2, 2020, public notice of a Public Hearing concerning amending and adding Plaquemine Code of Ordinances Chapter 23, Table 3.1: Minimum lot and yard size requirements within the Zoning Districts; and

WHEREAS, the Plaquemine Planning and Zoning Commission, at its meeting on January 7, 2020, after a public hearing, rendered and submitted to the Mayor and Board of Selectmen a recommendation concerning amending and adding Plaquemine Code of Ordinances Chapter 23, Table 3.1: Minimum lot and yard size requirements within the Zoning Districts; and

WHEREAS, the Mayor and Board of Selectmen, published in the Plaquemine Post/South, official journal for the City, on January 23, 2020, January 30, 2020 and February 6, 2020, public notice of a Public Hearing on the Planning and Zoning Commission's recommendation concerning amending and adding Plaquemine Code of Ordinances Chapter 23, Table 3.1: Minimum lot and yard size requirements within the Zoning Districts and the Mayor and Board of Selectmen intention to adopt an ordinance on the recommendation of the Plaquemine Planning and Zoning Committee at its meeting on February 11, 2020; and

WHEREAS, the Mayor and Board of Selectmen, have determined that the recommended ordinance will substantially and significantly reduce the number of substandard lots of record in Zoning Districts R-6 and R-4; and

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Board of Selectmen of the City of Plaquemine, Louisiana, in legal session, that Code of Ordinances of the City of Plaquemine, Louisiana, Chapter 23, Sections 41(d), Section 42(d) and Table 3.1 is hereby amended as follows:

SEC. 23-41. R-6 Residential District

- (a) *Permitted Uses*: The following uses are permitted in the R-6 district: single family dwelling, multi-family dwelling limited to duplex (limit 60-foot width, one per lot); condominium (limit 60-foot lot width, one per lot); bed and breakfast inn, garage apartment, preschool through college preparatory, public library, public safety building, garden, golf course, governmental building, public playground/park, townhouse (limit 60 foot lot width, one per lot)
- (b) *Special Uses*: The following uses and buildings may be permitted in the R-6 district subject to the restrictions contained in Sec. 23-123 of this chapter: beauty/barber shop (no signage allowed), professional office with two or less employees, includes principal and no signage allowed, storage only building, church, club/lodge, cultural building.
- (c) Set Back Restrictions: Buildings in the R-6 district must meet the following minimum set back restrictions:

Required Front (min. Feet) 25

Required Side (min. Feet) 10

Required Rear (min. Feet) 10

(d) Height and Area Restrictions. Buildings and lots in the R-6 district must meet the following height and area restrictions:

Lot Area (min. Square feet) 6000

Lot Width (min. Feet) 50

Building Height (max. Feet) 35

SEC. 23-42. R-4 Residential District

- (a) *Permitted Uses*: The following uses are permitted in the R-4 district: single family dwelling, multi-family dwelling limited to duplex (limit 60-foot width, one per lot, see lot restrictions); bed and breakfast inn, condominium (limit 60-foot lot width, one per lot), domestic shelter, garage apartment, garden, governmental building, public library, public safety building, preschool through college preparatory, townhouse (limit 60-foot lot width, one per lot)
- (b) *Special Uses*: The following uses and buildings may be permitted in the R-4 district subject to the restrictions contained in Sec. 23-123 of this Chapter: beauty/barber shop (no signage allowed), professional office with two or less employees, includes principal and no signage allowed, storage only building, church, club/lodge, cultural building.
- (c) Set Back Restrictions: Buildings in the R-4 district must meet the following minimum set back restrictions:

Required Front (min. Feet) 20

Required Side (min. Feet) 5

Required Rear (min. Feet) 10

(d) Height and Area Restrictions. Buildings and lots in the R-4 district must meet the following height and area restrictions:

Lot Area (min. Square feet) 4500

Lot Width (min. Feet) 40

Building Height (max. Feet) 35
